

## VICTORIA COUNTY BOARDS AND COMMISSIONS

### VICTORIA REGIONAL AIRPORT – three year terms

Meets the fourth Thursday each month at 9:00 a.m. 609 Foster Field Dr.

(Five members appointed by County Commissioners' Court)

#### Function:

Consider planning, development, construction, maintenance operation, regulations and protection of the airport.

### CHILD WELFARE BOARD – four year terms

Meets the second Wednesday of every month at 4:00 p.m. at Texas Family & Protective Services, 2306 Leary Lane (Up to 14 Board Members appointed by County Commissioners' Court)

#### Function:

To review budget and approve expenditures concerning special needs of children and families as circumstances arise.

### CITIZENS MEDICAL CENTER BOARD OF MANAGERS – two year terms

Meets the third Wednesday each month at 7:30 a.m., Hospital Board Room  
2701 Hospital Drive.

(Eight members appointed by County Commissioners' Court, County Judge is an Ex-Officio Member and may vote to break a tie vote)

#### Function:

Selection, employment and annual review of hospital Administrator, approval of administrative reports, payroll and personnel changes, accounts payable, monthly operating and medical staff reports.

### VICTORIA COUNTY PUBLIC HEALTH BOARD – three year terms

Meets quarterly on the third Friday of month, 12:00 noon – Health Department  
2805 N. Navarro

(Nine members to consist of three physicians, one dentist, and at least one nurse)

Four appointed by County Commissioners Court, Five appointed by City Council.

#### Function:

To advise director on the overall operation of the Victoria County Public Health Department, on matters of public health and on policies of the department.

### GULF BEND BOARD OF TRUSTEES – two year terms

Meets the fourth Tuesday of each month at 12:00 noon, 6502 Nursery Drive

(Nine board members from Victoria, Dewitt, Calhoun, Goliad Jackson, Lavaca and Refugio Counties.

Two members from Victoria County appointed by County Commissioners' Court)

#### Function:

Establish governing policies of the Center, and provide direction and oversight of all authority functions and service provisions offered to the people served.

### HISTORICAL COMMISSION – two year terms

Meets the first Monday every other month starting in January, 7:00 p.m., Victoria County Archives Building, 205 W. Goodwin.

(Members appointed in January of odd numbered years by Commissioners' Court)

#### Function:

To establish goals and policies involving preserving the past for the future.

### PUBLIC LIBRARY ADVISORY BOARD – three year terms

Meets the third Wednesday of every month at 12:00 noon in the Bronte Room of the Victoria Public Library, 302 N. Main

(Ten members to consist of four appointed by Commissioners' Court, four appointed by City Council and 1 appointed jointly by City/County)

#### Function:

To develop and establish policies. Review budget proposed by Library Administration and give recommendations to City/County prior to final adoption of budget.

### NAVIGATION DISTRICT – two year terms

Meets the third Tuesday of each month at 1:00 p.m. 1934 F.M. 1432.

(Five members appointed by Commissioners' Court)

#### Function:

To oversee the management and operation of the Port of Victoria and establish policies concerning waterway transportation capabilities to maintain and create economic opportunities to the region.
